\*\*\* Note \*\*\*

1. Clergy members requesting an extension to their leave must do so by written request. (§354.1a)
2. Members seeking to end their leave of absence with an appointment by the bishop must submit their written request to the Board of Ordained Ministry and cabinet six months prior to the session of the annual conference. (§354.4)
3. When clergy members do not request an extension of the leave of absence annually, or do not indicate willingness to itinerate at the end of the five-year period, the Board of Ordained Ministry may recommend location or termination of conference membership.
